Coalition Group:

A conference call was held with the coalition members to inform them that it looks like the dig bill that is in front of the legislative committee will not pass due to the Building Contractors and the Realty Board now opposing this change. Those groups do not want to add another enforcement agency when they are already covered by the Contractor's Licensing Board and they suggested that the licensing board could be a route for dig law enforcement. The issue with that is that board only has authority over licensed contractors, after discussion our local council voted to support the original draft and send a letter to the Coalition and Legislator's showing that support.
